Introductions from the Executive

General Discussion

Alexis T asks if we know what days of the week each tier will play this season and if we know the draft date.

Jo M notes that fields are not open until April 18th so the season may start at the earliest April 20th weekend. The largest amount of fields are available Mon/Wed because those fields were rolled over. Until Jo talks to the City, we can't confirm days of play and field availability.

The draft may be a real draft at one of the indoor facilities. We're considering what that would look like and what format that would take.

Cassy J asks what would happen if someone didn't want to participate in a real draft. There are no answers at this time. The format still needs to be shaped. Annette H notes that we recognize that it may be a bit uncomfortable for new players to participate but it does make it so much easier for teams to decide on their picks with more information than a name on a registration form.

Anoop B asks how long the season will be and how many games will be played. These questions can't be answered at this time as fields aren't released from the City until the end of January and the number of teams per tier isn't formalized yet so games per tier can't be determined.

We will get team input regarding the schedule at the February 26th meeting.

Jo M notes that fields will be closed at Mac Island May 9-15 for the Slurpee cup so our schedule will probably start with 3 weeks of play and then a week off during this field closure. There are many variables to creating a schedule. Jo M suggests that prior to the Feb 26th meeting, team reps make sure that they discuss with their teams what they would like their season to look like.

Also at the February meeting we bring forward the initialization of the Social Committee and try to create a year end event to share with all members.

Tracey E would like to ask teams (again) to submit one cheque per team where possible when submitting their registration fees.
